## Contributor's Agreement

This agreement is made on \_\_\_\_\_, between *Chiropractic Economics* magazine/The Doyle Group, 5150 Palm Valley Road, Suite 103, Ponte Vedra Beach, Fl 32082 (“publisher”) and \_\_\_\_\_ (“contributor”) regarding the publisher’s acquisition of rights in all materials submitted (“the articles”) for publication in *Chiropractic Economics*.

**1. Due date.** Contributor shall write the articles and deliver the same to publisher on or before the deadline agreed to when an individual assignment is given.

**2. Changes.** Contributor shall promptly make such changes in all articles as the publisher may request. *The publisher shall have the right to edit, revise, augment, re-title, and adapt all articles and to cause others to make such changes in the articles as the publisher may deem appropriate.* Further, the publisher shall have the right to check the articles for accuracy, and contributor shall be available to and cooperate with the publisher in such checking.

**3. Rights.** The publisher shall have the exclusive right and license under all copyrights throughout the world to first publish the articles, and to republish and authorize the republication thereof in whole or in part, in English, or in translation, and in any and all media (including electronic media, CD-ROM, Web sites and any other electronic system or medium now existing or hereafter developed).

Contributor grants publisher rights to the articles, without fee, when reprinted or copied for reader convenience. *Contributor shall not authorize or permit any publication of the articles — including online (Web) — except with the prior written consent of the publisher in each instance.* If the publisher publishes the article online, contributor is permitted to provide a link consisting of a reference to the article to the article on his/her Web site.

**4. Authorship.** In any publication of the articles, the publisher shall, or shall by contract, require any licensee to refer to you as author of the articles, and the publisher may use or authorize the use of your name and pertinent biographical data in connection with the advertising or promotion of any publication of the articles.

**5. Illustration.** The publisher may illustrate the articles with photographs or illustrations or both and contributor will, when requested, supply such photographs or illustrations and/or assist in the writing of captions thereof.

**6. Fact checking.** Contributor will verify all facts in the articles and will furnish the checking material to the publisher at the publisher's request, although the publisher shall have the right to check the article for accuracy.

**7. Competitive articles.** Contributor will not write and authorize the publication of any material that is on the same subject as any submitted articles that could be reasonably deemed competitive with the article until at least 90 days after first publication of the articles by the publisher.

**8. Not published.** If the publisher shall decide for any reason not to publish a given article, the publisher shall give contributor prompt notice of such decision and upon the giving of such notice, all rights in the articles shall revert to contributor; the agreement for that article will terminate; and neither party hereto shall be under any further liability or obligation to the other.

**9. Originality.** Contributor warrants and represents that the articles will be original, will not infringe on any copyright, invade any right of privacy, contain any libelous material, or infringe or violate any other right of any other person or entity.

Contributor will indemnify and hold harmless the publisher and its licensees from any claim, suit, damage, loss, or expense (including reasonable attorney's fees) arising out of any breach or any allegation that if true would constitute a breach of any of the foregoing warranties or representations.

**10. Integrity.** *Contributor affirms that he or she has not been convicted of a felony. If applicable, the contributor also affirms that he or she currently holds or is eligible to hold a license in his or her profession.*
