JUST THE BASICS

TELEMEDICINE: STAY CONNECTED—GET PAID

1. Standard codes

99201-99215 (Place of Service: 02 / Modifier: 95) Many plans prefer/require standard E&M codes for virtual visits. Anthem has given notice they will pay for telephone calls and other telehealth for the next 90 days referencing the standard E&M codes for use.

2. Online Digital/Video Services (Place of Service: 02 / Modifier: 95) Patient Initiated online digital Evaluation and Management services for an <u>established</u> patient. Time is cumulative over a seven day period. New patients may also be covered but that is subject to each carrier. The Federal government has temporarily allowed the use of non-secure platforms such as *Skype and Facetime* even though they are not HIPAA compliant.

PT BENEFIT

Chiropractors/Acupuncturists. Remember to check PT benefits when verifying coverage. Many policies have a PT benefit when there is no chiropractic benefit. Ask the representative what the PT benefit is and "Is it accessible by a Chiropractor/Acupuncturist?". Many times they respond yes if they are practicing within the scope of their license, which they are. Additionally you can access the PT benefit after the chiro/acup benefit is exhausted.



BLUE SHIELD

Chiropractor: Use level 2 or lower E&M codes for new and established patients.

Example: Use 99202, not 99203..... Use 99212, not 99213

MEDICARE

Dx1 Must be subluxation (M99.01 M99.02 M99.03)

Dx2 Must support Dx1 (Ex. M99.01 cervical / M54.2 cervicalgia)

(M99.02 thoracic / M54.6 pain in thoracic spine)

(M99.03 lumbar / M54.5 low back pain)

Use modifier AT for subluxation code

Use modifier GP for physical therapy codes / (Chiros must use GY also)
